CCA Faith Statement

CCA believes in the scriptures of the Old and New Testaments as verbally inspired of God, and inerrant in the original writings, and that they are of supreme and final authority in faith and life. We believe in one God, eternally existing in three persons: Father, Son, and Holy Spirit. We believe that Jesus Christ was begotten by the Holy Spirit, born of the Virgin Mary, and is true God and true man. We believe that man was created in the image of God, that he sinned and thereby incurred not only physical death, but also spiritual death which is separation from God; and that all human beings are born with a sinful nature, and in the case of those who reach moral responsibility, become sinners in thought, word and deed. We believe that the Lord Jesus Christ died for our sins according to the Scriptures as a representative and substitutionary sacrifice, and that all who believe in Him are justified on the ground of His shed blood. We believe in the resurrection of the crucified body of our Lord, in His ascension into Heaven and in His present life there for us, as High Priest and Advocate. We believe in "That blessed Hope," the personal, premillennial, and imminent return of our Lord and Savior, Jesus Christ. All who receive by faith the Lord Jesus Christ are born again of the Holy Spirit and thereby become children of God. We believe in the bodily resurrection of the just and the unjust, the everlasting blessedness of the saved, and the everlasting, conscious punishment of the lost.

PARENT COOPERATION AGREEMENT

In making application to have my child attend Calvary Christian Academy, I agree to the following conditions in the spirit of Christian cooperation:

1. I agree to support the goal of Calvary Christian Academy: To develop students of character and conduct who will live for the glory of God and the good of society.
2. I understand and agree to comply with the school's policy on regular weekly church attendance for all students. Furthermore, I agree to faithfully attend a church where God's Word is preached. I realize that failure to comply may result in my child's dismissal from school.
3. I agree to support the guidelines, standards of conduct and the dress code of Calvary Christian Academy as contained in the Parent/Student Handbook. I understand that Calvary Christian Academy does not tolerate profanity in speech, obscenity in word or action, dishonor to God and His Holy Word, or disrespect to the personnel of the school. In the event of my child's failure to comply with these standards, I hereby authorize the school to apply such corrective measures as it deems necessary (corporal punishment is not used).
4. I understand that students may be disciplined or expelled by the school if, during off-school hours, they engage in conduct that violates biblical principles, dishonors God, or brings reproach on the name and reputation of the school.
5. I agree to insure that my child attends all classes regularly, is punctual and has transportation from the Academy premises at the close of the day. I recognize that my child may be retained or credits withheld for excessive absences (over 12 per semester).
6. I agree to support the school with a willing and cheerful attitude. I will not criticize the administration or faculty in the school in public or in the presence of my child. Instead, I will seek a private consultation with the administration.
7. I give permission for my child to take part in all school activities, including sports and school sponsored trips away from the school premises. I absolve the school from liability to my child or myself because of any injury to my child at school or during any school activity. (This statement does not absolve the school from its legal obligations to the student, i.e., negligence.)
8. I hereby pledge to fulfill my financial obligations to Calvary Christian Academy on the date due (first day of the month). I understand that the late fees will be assessed when payment has not been made by the tenth of the month. The late fee is \$20 per month.
9. As evidence of our support as parents, we agree to attend, whenever possible, all orientation and informational parent meetings.
